

# UTASS Briefing: 22nd November 2022.

## **AVIAN INFLUENZA (BIRD FLU).**

Bird Flu has been on the increase amongst wild birds resulting in the Government introducing compulsory control measures to try and limit the spread.

Since the 7<sup>th</sup> November there has been a national legal requirement to house all poultry and captive birds.

There are no exceptions for small “back yard” flocks or birds kept as pets and includes ducks, geese and game birds.

On the 21<sup>st</sup> November an outbreak was confirmed near Barnard Castle which has introduced a 3k protection and 10k monitoring zones with extra restrictions and a licensing regime.

It is also a legal requirement to register your flock if you have more than 50 birds in total.

Voluntary registration for those with less than 50 birds is strongly encouraged.

The relevant forms can be downloaded from the gov.uk website or at UTASS.

## **SHEEP AND GOAT ANNUAL INVENTORY.**

All keepers of sheep and goats need to complete an annual inventory showing the number of animals on their holding on **1<sup>st</sup> December 2022**.

This needs to be done by 31<sup>st</sup> December or it may incur additional inspections and possible penalties.

Those keepers who have done this online in the past should receive an advisory email which will be followed by an email on 1<sup>st</sup> December with a link to a partially prepopulated form.
